ARTICLES OF INCORPORATION
OF
THE FLORIDA JUSTICE PROJECT, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, Chapter 617, hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be: The Florida Justice Project, Inc.

ARTICLE II: PRINCIPAL OFFICE

2. To advocate on behalf of persons in confined environments;
3. To conduct research on confined environments; and
4. To work towards the elimination of confined environments in society.
