ARTICLES OF INCORPORATION OF TRUE KNOWLEDGE, INC. A FLORIDA NONPROFIT CORPORATION

Article 1.

Name.

The name of the Corporation is: TRUE KNOWLEDGE, INC.

Article 2.

Duration.

The duration of the Corporation is perpetual.

Article 3.

Purposes.

The purpose of the Corporation is as follows:

This Corporation is a not-for-profit corporation organized under chapter 617 of, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to provide to the public, of all ages, cultural materials of an educational and critical thinking nature in an innovative and fresh manner through all the various forms of media.

To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to the members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members. The Corporation shall have Voting members, who shall be elected (and may be removed) by the Voting members, and who shall have the rights and privileges of members of the Corporation.
