# **Articles of Corporation**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

#### Article I

LIVING HOPE COMMUNITY CHURCH of Miami, INC. A Florida Non For Profit Corporation

#### Name
