Articles of Incorporation

The undersigned incorporator, for the purpose of forming a corporation under the *Florida Not for Profit Corporation Act*, hereby adopt(s) the following **Articles of Incorporation**:

Article I

Name

The name of the corporation shall be Living Hope Community Church of Miami, Inc.

Article II

Principal Office

The principal place of business shall be 14540 S. W. 136 St., Suite #210, Miami, FL 33186, and the mailing address shall be P. O. Box 160307 Miami, FL 33116.

Article III

Purpose(s)

The specific purpose for which the corporation is organized is religious, not for profit (church).

Article IV

Manner of Election of Directors

The Directors of Living Hope Community of Miami Inc. shall be appointed by the President (Teaching Pastor) and/or Vice President (Executive Pastor). Each director appointed by the President and/or Vice president will serve until death, resignation, or removal. The President and/or Vice president will have authority to remove and replace directors at their discretion. They were appointed March, 1998.

Article V

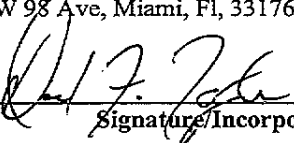
Initial Registered Agent and Street Address
