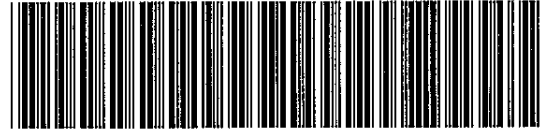

**ARTICLES OF DISSOLUTION  
OF  
ACADEMY PREP CENTER OF MANATEE, INC.**

ACADEMY PREP CENTER OF MANATEE, INC., a Florida not-for-profit corporation, (the "Corporation"), is hereby dissolved under the laws of the State of Florida.

**ARTICLE I  
Name**

The name of the Corporation is: ACADEMY PREP CENTER OF MANATEE, INC.

**ARTICLE II  
Member and Trustee Approval of Dissolution and Plan of Distribution**

Dissolution of the Corporation and the Plan for Distribution of Assets upon Dissolution that is required by Florida Statutes Section 617.1406 which is attached hereto and incorporated herein, was authorized on April 5, 2005, by the written consent of the Corporation's sole Member in accordance with Florida Statutes Section 617.0701 and by the unanimous written consent of the Corporation's Trustees in accordance with Florida Statutes Section 617.0821, which votes are sufficient for approval of the dissolution and the Plan for Distribution of Assets upon Dissolution.

**ARTICLE III  
Distribution of Assets to Sole Member**

All debts, obligations and liabilities of the Corporation have been paid. All remaining property and assets of the Corporation, if any, have been distributed to the sole Member of the Corporation, which is exempt as an organization described in Section 501(c)(3) of the Internal Revenue Code of 1986 as required by Article VI of the Corporation's Articles of Incorporation and in accordance with the Plan for Distribution of Assets upon Dissolution adopted by the sole Member and Trustees of the Corporation, which is attached hereto and incorporated herein by this reference. This Plan for Distribution of Assets upon Dissolution is being filed pursuant to Florida Statutes Section 617.1406.
