The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation

ARTICLE I  
**NAME**

The name of this corporation shall be: Dominion and Power Church Of God In Christ, Inc.

ARTICLE II

**Principle place of business and mailing address**

ARTICLE III  
**Purpose**

The purpose for which the corporation is organized is:

To provide the means, facilities, services and all other activity necessary for providing the worship of God by the members of this corporation (church).

ARTICLE IV

**Manner of election of Officers**

The manner in which the Officers are elected or appointed is as follows:

The Pastor has all executive powers. The Pastor appoints a Board of Trustees, which is responsible for the execution of the purpose of this corporation both administrative and financial. All other corporation officers are elected by members of the corporation.

ARTICLE V

**Limitation of Corporate power**

The provisions of this charter may be modified, altered or amended by a two-thirds (2/3) majority vote of all members of the Board of Trustees. As soon as the proposed alterations or amendments shall have been adopted as herein provided, the result of the vote shall be announced by the Secretary and declared adopted by the Pastor, and filed with the Secretary of the State of Florida, where upon such alterations or amendments shall be full force and effect.

**Property Dissolution**
