## ARTICLES OF INCORPORATION

of

The Key West Dharma Center of Universal Spirituality, Inc.  
A Nonprofit Corporation

*The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

### Article I      NAME

The name of the corporation shall be: *The Key West Dharma Center of Universal Spirituality, Inc.*

### Article II      PRINCIPAL OFFICE

The principle place of business and mailing address of this corporation shall be: *425 Southard St. Key West, FL 33040*

### Article III      PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are):

- A.      *This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are: Provide the public with a safe, supportive, sacred environment for each individual's spiritual unfolding.*
- B.      *This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.*
- C.      *To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.*

### Article IV      MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is: *As stated in the Bylaws of this corporation.*

**Article VII ADDITIONAL PROVISIONS**

- A** Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.
