The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is **COOPERATIVE HOUSING & DEVELOPMENT, INC.**, (hereinafter, "Corporation).

ARTICLE 2 - PURPOSE OF CORPORATION


