ARTICLES OF

INCORPORATION

The undersigned incorporator, a natural person 18 years of age or older and a Florida Citizen, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE ONE - NAME

The corporation's name shall be:

The Peacemaker Foundation for Economic Development, Inc.

ARTICLE TWO - PRINCIPAL OFFICE

The corporation's principal place of business and mailing address shall be:

ARTICLE THREE - PURPOSES

The purposes for which the corporation is organized are exclusively charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

Notwithstanding any other provisions of these Articles, the organization shall not carry on any other activities not permitted to be carried on:

- a. by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code or United States Internal Revenue Law; or
- b. by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, the corresponding provisions of any future United States Internal Revenue Law, or any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

At all times the following shall operate as conditions restricting the operations and activities of the corporation: no substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public; and the

corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
