THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOTPERMIDTTED TO BE CARRIED ON (A) BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501© (3) OF THE INTERNAL REVENUE CODE OF 1954 (OR THE CORRESPONDING PROVISION OF ANY FUTJURE UNITED STATES INTERNAL REVENUE LAW) OR (B) BY A CORPORATION. CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170 © 2 OF THE INTERNAL REVENUE CODE OF 1954 OR THE CORRESPONDING PROVISION OF ANY FURTYHER UNETED STATES REVENUE LAW.
