## ARTICLES OF INCORPORATION

OF

### INDIAN RIVER BASS ANGLERS, INCORPORATED

(A Non-Profit Organization)

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation is **INDIAN RIVER BASS ANGLERS, INCORPORATED**, herein after referred to as the "corporation."

#### ARTICLE II

The initial street address of the principal office of this corporation is 485 Ponoka Street, Sebastian, Florida 32958. The Board of Directors may from time to time move the principal office to any other address in Florida.

#### ARTICLE III

The duration of the Corporation is perpetual.

#### ARTICLE IV

The specific purposes for which this corporation is organized is as follows:

A. To promote the sport of Bass fishing through the use of organized tournaments and events.

B. To promote knowledge and conservation of both Florida's inland waterways and the various types of wildlife associated with these waterways.

#### ARTICLE V

The method of election of Directors shall be as stated in the bylaws.

#### ARTICLE VI
