#### ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE TALLAHASSEE. FLORIDA

JUPITER BASEBALL UMPIRES ASSOCIATION, INC.

The undersigned, acting as Incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

#### ARTICLE I - NAME

The name of this Corporation shall be:

JUPITER BASEBALL UMPIRES ASSOCIATION, INC.

## ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address of this Corporation shall be:

#### ARTICLE III - PURPOSE

The specific purposes for which the Corporation is organized are:

A. The Objects and Purposes of this Corporation shall be devoted to receive and maintain a fund or funds of real or personal property, or both, and subject to the restrictions and limitations hereafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, literary, or educational

purposes, either directly or by contributions to organizations that qualify as Exempt Organizations under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended, excepting that this corporation shall not organize, operate, or conduct an institution of the kind excluded by the laws of the State of Florida.

- B. No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, or offer of the Corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no member, trustee, or officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.
- C. Notwithstanding any other provisions of the Articles of Incorporation, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended, or by an organization, contributions to which are

deductible under Section 170(c)(2) of such Code and regulations as they now exist or as they may hereafter be amended.

#### ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors are elected or appointed shall be as provided in the By-Laws of this Corporation.

#### ARTICLE V - LIMITATION OF CORPORATE POWERS

The corporate powers of this Corporation are as provided in Section 617.0302, Florida Statutes.
