OF

ONE: The name and address of this principal corporation is GOLDEN TOUCH LIVING CARE, INC. 5487 GATE LAKE RD. TAMARAC, FL. 33319 in BROWARD County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a non-profit Public Benefit Corporation and is organized to aid mankind through Economic and Community Development Programs. The corporation is organized under the Non-profit Public Benefit Corporation Laws. The programs will consist of Economic Development Programs, but shall not be limited to: Homelessness, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing Job Training, Counseling, Employment, and other support programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

FIVE:

- (a) This corporation is organized and operated exclusively for religious purposes within meaning of Section 501 (C) (3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

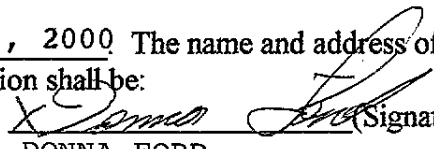

(b) The property of this corporation is irrevocably dedicated to Public Benefit purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer, or member thereof, or the benefit of any private person.

EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payments of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for Public Benefit or Religious, under Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Superior Court of the County in which the principal office or organization as said Court shall determine which are organized and operated exclusively such purposes.
