ARTICLE III PURPOSE(S): The specific purpose(s) for which the corporation is organized is(are): Education, within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any-future federal tax code, will be the exclusive purpose of *Imagine World Health, Incorporated*. This shall include, for the purpose of education, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V DISSOLUTION: In the event of dissolution of *Imagine World Health Incorporated*, all assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes. These assets shall include, but not be limited to, financial assets and property.

ARTICLE IX AMENDMENTS TO THE ARTICLES OF INCORPORATION AND THE BYLAWS: The Board of Directors may amend the Articles of Incorporation or the Bylaws by a majority vote of the Board of Directors.
