OF

a Florida Corporation

The undersigned incorporator, for the purpose of forming a corporation of Korean Association of Northwest Florida, Inc. under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

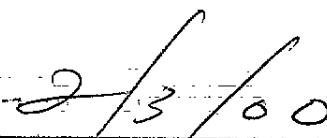
