ARTICLES OF INCORPORATION

OF

P. SANDERS MINISTRIES, INC.

The undersigned hereby associates themselves for the purpose of forming a corporation not for profit under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be P. SANDERS MINISTRIES, INC.

ARTICLE II

The purpose of the corporation shall be to be a Christian church and place of worship.

ARTICLE III

The principal place of business of the corporation shall be 1593 Helena Street, P. O. Box 8804, Jacksonville, Florida 32239.

ARTICLE IV

The duration of the corporation shall be perpetual.

ARTICLE V

The number of directors thereof, which must not be less than three and which may be any number in excess thereof, and the names and residences of those selected for the first year and until their successors shall have been elected and shall have accepted office are as follows:

All future directors will be appointed by the director at an annual board meeting.

ARTICLE VI

Whether the voting power and the property rights and interest of each member shall be equal, or unequal, and if unequal these articles shall set forth a general rule applicable to all members by which the voting power and the property rights and interest, respectively, of each member may and shall be determined and fixed, but the association shall have power to admit new members, who shall be entitled to vote and to share in the property of the association with the old members, in accordance with such general rule. This provision of the articles of incorporation shall not be altered, amended or repealed except by unanimous written consent or the vote of all the members.

ARTICLE VII

Said articles must be subscribed by the original members and acknowledged by one of them before an officer authorized by the law of this state to take and certify acknowledgments of deeds of conveyance, and shall be filed in accordance with the

provisions of law, and when so filed the said articles of incorporation or certified copies thereof shall be received in all the courts of this state and other places as prima facie evidence of the facts contained therein.

ARTICLE VIII
