## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation not for profit under the provisions of Chapter 617 of the Florida Statutes and the Florida General Corporation Act, do hereby adopt the following articles of Incorporation.

#### ARTICLE I

The name of this corporation shale be "Born Again Missionary Baptist Outreach Ministry, Inc."

#### ARTICLE II

This corporation shall have a perpetual existence.

#### ARTICLE III

- (A) This is a nonprofit corporation organized solely for general charitable purposes pursuant to Part I of Chapter 617 of the Florida Statutes.
- (B) The specific and primary purpose for which this corporation is organized and the business and objects to be carried on and promoted by it is to provide an Evangelical Gospel Ministry and other religious activities, particularly as follows:
- (1) To organize, operate, and maintain a church, the object of which shall be to provide a redemptive fellowship in which the Word of God is preached by men and women divinely called, to administer the sacrament of Holy Communion, and Baptism according to Christ's own appointment; to advance Spiritual growth and enlightenment, moral and purity among it's own students and people of the community in which it is located; to establish, conduct, maintain, and supervise churches and other institutions connected therewith of a religious, educational, charitable and benevolent character shall, nevertheless, be created as a Great Commission Bible Church, and, in accordance with all other provisions contained in the character, to prepare Christians for ministry of the gospel of Jesus Christ; to publish and disseminate religious newspapers, books, tracts, tapes and the like, and to obtain funds by gifts, collections, requests and otherwise for the dispensing of religious literature, to use all lawful and useful methods and means of education and aid of persons who personally attend service.
- (2) Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the corporation is organized, subject to the requirement of Section 501 (C)3 of the Internal Revenue code of 1954, as amended.

#### ARTICLE IV

Membership in this corporation shall consist of individuals who are members in good standing of any church, or who are interested in promoting the gospel of Jesus Christ who have agreed to be bound by the Articles of Incorporation, by it's by-laws. This corporation shall have no capital stock and membership shall be evidenced by certificates of membership. Memberships shall not be transferable by assignment or sale or by inheritance.

#### **ARTICLE V**

The street address of the Initial Registered office of this corporation is 2920 Crutchfield Road, Lakeland (Polk County) FL 33805, and the mailing address of the Initial Registered Office is P. O. Box 93366 Lakeland, FL 33804-3366. The name of the Registered Agent of this Corporation at that address is James Fox. The principal place of business shall be the same.

## **ARTICLE VI**

The power of this corporation shall be exercised by a Board of Trustees. The number of Trustees of this corporation shall initially be three (3) persons, provided, however that such number may be changed by a by-law duly adopted by the members.

Trustees elected at the First Annual Meeting and all times thereafter, shall serve for a term of one (1) year until the next annual meeting of members following the election of Trustees.

## ARTICLE VII

Upon the dissolution of the corporation or the termination of it's affairs, the assets of the corporation shall be distributed exclusively to Charitable Organizations which qualify under the provisions of section 501 (C) 3 of the Internal Revenue code and Regu-lations as there may exist or as they may hereafter be amended.

# ARTICLE VIII

Amendments to these Articles of Incorporation may be proposed by a resolution adopted by the Board of Trustees, and presented to a quorum of members of the corporation exempt for their vote. Amendments may be adopted by the vote of two-thirds (2/3) of a quorum of members of the corporation.
