AMENDMENTS TO THE ARTICLES OF INCORPORATION OF TRADEWINDS AT SEBASTIAN LAKES HOMEOWNRS ASSOCIATION, INC.

Article X of the Articles of Incorporation of Tradewinds at Sebastian Lakes Homeowners Association, Inc. titled "Amendments," is amended as follows:

ARTICLE X

Amendments

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

- 10.1 Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 10.2 A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by no less than ten (10) members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary at or prior to the meeting. Except as elsewhere provided.
 - a. Such amendment must be approved by not less than seventy-five percent (75%) of the Board of Directors; and, by not less than seventy-five (75%) of the total vote of Class A and Class B members of the Association a majority of the voting interest at a meeting of the membership at which a quorum has been attained; or
 - b. By not-less-than eighty percent (80%) of the total vote of Class A and Class-B members of the Association.
- 10.3 Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of members without approval in writing by all members and the joinder of all record owners of mortgages upon the Owner's individual lot. No amendment shall be made that is in conflict with the Declaration of Restrictions on Real Estate or the Architectural Guidelines and Rules and Regulations, if promulgated.
- 10.4 A copy of each amendment shall be certified by the Secretary of State, State of Florida, and shall be recorded in the public records of Indian River County, Florida.
