ARTICLES OF INCORPORATION .

OF

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is ADDISON RESERVE WOMEN'S CLUB, INC., (hereinafter, "Corporation).
