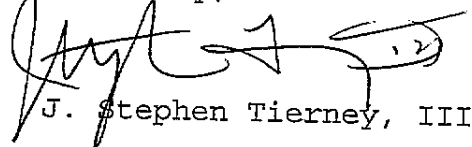

ARTICLES OF INCORPORATION
OF
NEW BEGINNINGS MINISTRIES OF GOSPEL TEMPLE, INC.
(a Florida not-for-profit corporation)

ARTICLE I - NAME

The name of the corporation is NEW BEGINNINGS MINISTRIES OF GOSPEL TEMPLE, INC.

ARTICLE II - PLACE OF BUSINESS

The place in this state where the principal office of the Corporation is to be located is 706 Ohio Avenue, Fort Pierce, St. Lucie County, Florida.

ARTICLE III - DURATION

This Association shall be of perpetual duration.

ARTICLE IV - PURPOSE

This corporation is organized exclusively for religious and/or charitable purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 706 Ohio Avenue, Fort Pierce, Florida 34950 and the name of the initial registered agent of this corporation at that address is Michael Brown. The mailing address of the corporation is 706 Ohio Avenue, Fort Pierce, FL 34950.

ARTICLE VI - BOARD OF DIRECTORS

The corporation shall have five (5) directors and the number of directors may be increased or decreased from time, but may never be less than three (3). The names and addresses of the persons who are the initial directors of this corporation are as follows:

The method of election of directors shall be stated in the Bylaws.

ARTICLE VII - RESTRICTIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, directors, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the

corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII - DISSOLUTION OF CORPORATION

Upon the dissolution of the corporation, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purposes. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX - OFFICERS.

The affairs of the Association shall be administered by the Officers designated by the Bylaws. The Officers shall be elected by the Board of Directors at its first meeting following the annual meeting of the Association, and they shall serve at the pleasure of the Board of Directors, as provided in the Bylaws.

ARTICLE X - INCORPORATORS
