ARTICLES OF INCORPORATION  
OF  
JACKSONVILLE BUZZ BASEBALL CLUB, INC.

The undersigned Incorporator of these Articles of Incorporation is a natural persons competent to contract and hereby forms a corporation under the Florida Not for Profit Corporations Act.

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is Jacksonville Buzz Baseball Club, Inc. and its principal office is located at 4575 Carriage Crossing Drive, Jacksonville, Florida 32258.

ARTICLE II. DURATION

This corporation is to exist perpetually.

ARTICLE III. PURPOSE

This corporation is organized to promote and encourage the athletic sport of baseball for youth; to promote and encourage the sport, pleasure, exercise, and recreation of youth through playing the game of baseball; and to manage and conduct the activities of a baseball team.

ARTICLE IV. MEMBERS

The coporation shall initially have one class of members consisting of three members. The initial members shall be Tim L. Fitzpatrick, Doug Skinner, and Daryl Rosenberger. Provisions for additional members and their qualifications shall be set in the bylaws of the corporation.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 4575 Carriage Crossing Drive, Jacksonville, Florida 32258 and the name of the initial registered agent of this corporation at that address is Tim L. Fitzpatrick. The stockholders shall have the power to establish branch offices, and to move the principal office to any other address in Florida.
