

# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF JEWISH CAPITAL ALLIANCE OF CENTRAL FLORIDA, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, this Florida not for profit corporation hereby adopts the following amendment to its Articles of Incorporation:

#### ARTICLE 1 - NAME
