We, the undersigned, with other persons being desirous of forming a nonprofit Corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of the corporation shall be BAY AREA HEALTH NETWORK, INC.
The address of the principal office of this corporation shall be P.O. Box 1669, Panama City, Florida, 32402. And the mailing address of the corporation shall be the same.

ARTICLE II

Said corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

ARTICLE III

The manner in which the directors are to be elected or appointed is as stated in the bylaws.

ARTICLE IV

The name and Florida street address of the initial registered agent is Jack G. Williams, Attorney at Law, 502 Harmon Avenue, Panama City, Florida 32401.


ARTICLE V

The name and address of the incorporator of these Articles is Charles G. Tucker, 1029 Huntingdon Road, Panama City, Florida, 32405.

ARTICLE VI

This corporation is to exist perpetually.
