Pursuant to the provisions of section 617.1006, Florida Statutes this Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted: (indicate article number(s) being amended, added or deleted)

ARTICLE V. PURPOSE

The purpose of the corporation shall be operated exclusively for religious charitable and education purposes and in the furtherance of such goals as authorized to do any or all activities which it is empowered to do Chapter 617 and 607 as appropriate; provided, however, that nothing herein shall be construed as allowing any activities which would jeopardize the corporation's tax-exempt status or otherwise be inconsistent with its classification as an organization described in Section 501© 3 of the Internal Revenue Code of 1986 as amended from time to time or any equivalent section of the Internal Revenue Code in effect at any time. Briefly outlined, the corporation shall carry among other religious activities the following operations:

- (1). Conduct church services, conferences and conventions and for the promotion of the gospel of Jesus Christ through radio, television, audio and video ministries.
- (2). Conduct benevolent activities locally and overseas including missions training and support network.
- (3). Conduct charitable work to help the needy and the homeless in our community and elsewhere in the world.

ARTICLE VI. DIRECTORS

This corporation shall have a governing Board of Directors to be headed by an Ordained Minister of the Gospel. There shall be five (5) directors on board. The number of directors may be increased or diminished from time to time by the By-Laws adopted by the members of Word of Faith Mission, Inc. The manner in which the directors are elected is as stated in the bylaws.
