**ARTICLES OF INCORPORATION OF
LEATHER UNIVERSITY, INC.**

The undersigned, acting as incorporators hereby forms a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Charter of Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be LEATHER UNIVERSITY, INC.

ARTICLE II

The principal office of the Corporation is 1226 NE Fourth Ave, Ft Lauderdale Florida 33304. The principal mailing address shall be PO Box 11044 Ft Lauderdale Florida 33339.

ARTICLE III

The specific purpose for which the Corporation is organized is to promote safer sex practices through educational programming.

ARTICLE IV

The Directors shall be elected as provided for in the By-Laws of the Corporation.

ARTICLE V

The initial registered agent is Lawrence E A Fox, 1226 NE Fourth Ave., Ft Lauderdale Florida 33304.

ARTICLE VI

ARTICLE VII

Upon dissolution or final liquidation of Leather University, Inc. all of the assets of the corporation shall be turned over to a Not-for-Profit organization as defined in section 501 (c) of the tax code. Said organization to be chosen by the board of Directors at the time of liquidation or dissolution.

ARTICLE VIII

The period of this Corporation's existence is perpetual.

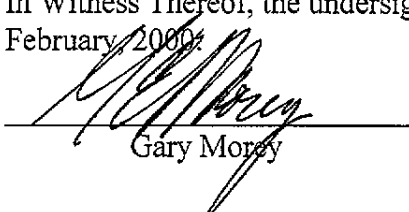
ARTICLE IX
