ARTICLES OF INCORPORATION
OF
TAU KAPPA EPSILON FRATERNITY OF UWF, INC.

I, the undersigned, being desirous of forming a corporation not for profit, for charitable, philanthropic and educational purposes, under the provisions of Chapter 617, Florida Statutes, and section 501(c)(7) of the United States Internal Revenue Code, do agree to the following:

ARTICLE I

The name of the corporation is TAU KAPPA EPSILON FRATERNITY OF UWF, INC., hereinafter "corporation". *Principal address is 8177 Squire Rd, Pensacola FL 32514*

ARTICLE II

The objectives and purpose of this corporation are to constitute and form the University of West Florida Chapter of Tau Kappa Epsilon Fraternity, an international service fraternity, and to do and undertake any and all acts, actions, or things consistent therewith under the Charter granted by Tau Kappa Epsilon International Fraternity.

ARTICLE III

The membership of this corporation and the manner of admission to membership in the corporation shall be set forth by the By-Laws of the corporation in conformance with the rules and regulations of Tau Kappa Epsilon International Fraternity.

ARTICLE IV

This corporation is to exist as a non-profit corporation under section 501(c)(7) of the Internal Revenue Code in perpetuity.

ARTICLE V

The officers of the corporation will be the Board of Advisors or subsequent body in conformance

with the rules and regulations of Tau Kappa Epsilon International Fraternity regarding operations of a chapter of said fraternity. The officers of the corporation will consist of at least a president, vice president, chapter president, and a chapter treasurer. The Board of Advisors will determine the election of officers and directors of the corporation by its own by-laws or rules.

The chapter may establish chapter officers, conforming to those as outlined in the rules and regulations of Tau Kappa Epsilon International Fraternity, to run the day-to-day activities of the chapter.

ARTICLE VI

The initial directors of the corporation shall be, and shall serve until their successors are duly elected according to the by-laws or rules of the Board of Advisors or chapter:

President: D Mark Niewiadomski, 8177 Squire Road, Pensacola, FL 32514

Vice President: D Eric Michael Cash, Jr., 6115 North Davis Highway #43B, Pensacola, FL 32504

Chapter President: D David M. Parent, 1460 E. Johnson Avenue #118, Pensacola, FL 32514

Chapter Treasurer: D Bryan J. Swihart, 11000 W. University Avenue, UWF, P.O. Box 32038, Pensacola, FL 32514

ARTICLE VII

Amendments to these articles of incorporation may be proposed by any member of the Board of Advisors or any other member of the corporation. Amendments will only become effective if approved by a 2/3 vote of the Board of Advisors.

ARTICLE VIII

The initial registered agent for the corporation shall be Mark Niewiadomski, 8177 Squire Road, Pensacola, FL 32514.

ARTICLE IX

No person, firm or corporation shall ever receive any dividends or profits from the undertakings

of this corporation and upon dissolution of this corporation all of this remaining assets shall be distributed to a similar organization not-for-profit, or to Tau Kappa Epsilon International Fraternity, as determined by the Board of Advisors.

IN WITNESS THEREOF, I, the incorporator of TAU KAPPA EPSILON FRATERNITY OF UWF, INC., have hereunto set my hand and seal this 14 day of February, 2000, for incorporation of a corporation not for profit under the laws of the State of Florida.
