ARTICLES OF INCORPORATION

FOR

Orchid Charities, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

ORCHID CHARITIES, INC.

ARTICLE II PRINCIPLE OFFICE

ARTICLE III PURPOSE(S)

The specific purposes for which the corporation is organized are:

1. for the purpose of providing spiritual nourishment to those in need;
2. for the purpose of providing food, shelter, and the basic human needs to homeless families and single women with dependant children;
3. for the purpose of providing job skills and education to the children and families of the homeless and the poor;
4. for the purpose of providing rehabilitation and counseling to those addicted to drugs and alcohol;
5. for the purpose of providing financial, educational and legal assistance to families in danger of losing the family home;

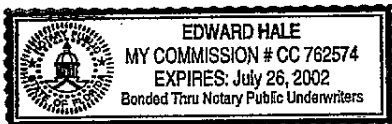
