# <u> ARTICLE III PURPOSE(S)</u>

The specific purposes for which the corporation is organized are:

- 1. for the purpose of providing spiritual nourishment to those in need;
- 2. for the purpose of providing food, shelter, and the basic human needs to homeless families and single women with dependant children;
- 3. for the purpose of providing job skills and education to the children and families of the homeless and the poor;
- 4. for the purpose of providing rehabilitation and counseling to those addicted to drugs and alcohol;
- 5. for the purpose of providing financial, educational and legal assistance to families in danger of losing the family home;

6. for the purpose of calling on people, business and civic interests within a community to raise the money necessary to fund the purposes as described above, and to spend that money within the county from which it is raised.

The initial board will be chosen by the incorporator and will serve for a period of two years. The board of directors will appoint officers and new directors by majority vote of the board.


