**NEW LIFE ALPHA OMEGA MINISTRIES INC.**

Come now New Life Alpha Omega Ministries Inc. which show the following amendments to it's Articles of Incorporation. The amendment of the Articles submitted by the incorporator.

The adoption date of the Amended Articles of incorporation was June 22, 2000.

*Article III is enlarged to include the following sentences:*

**(1)**

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future tax code.

**(2)**

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by organization, contributions to which are deductible under section 170(c) (2) of the internal Revenue Code, or corresponding section f any future federal tax code.

**(3)**

For housing our organization will provide decent, affordable housing to low income households.

**(4)**


In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations, described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State4, or local government for exclusive public purpose.

**(5)**

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) of any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 ( c ) (3) of the Internal Revenue Code, or corresponding section of any future tax code, or (b) by and organization, contributions to which are deductible under section 170 (c ) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
