**ARTICLES OF AMENDMENT
TO
AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF**

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Amended and Restated Articles of Incorporation:

1. Name. The name of the corporation is: MANASOTA ASSOCIATION FOR RETARDED CITIZENS, INC., (the "Corporation"). Document number of Corporation: N00000001350

2. Amendment. Article VII of the Corporation's Amended and Restated Articles of Incorporation is hereby amended so as to read, after Amendment, as follows:

"ARTICLE VII

BOARD OF DIRECTORS

The corporation's board of directors shall consist of three directors. The method of election or appointment of the directors shall be as provided by the bylaws. The names and address of the current directors are:
