The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

### Article I

The name of the corporation shall be Holy Tabernacle Church of Polk County, Incorporated.

### Article II

The location of the church shall be 4601 Baker Avenue in of Haines City, 33844-8284 state of Florida the County of Polk.

### Article III

The purpose of this organization is purely religious, moral, uplifting, and civic.

### Article IV

The membership of the organization shall consist of only those who have met the requirements of the By-laws of the Holy Tabernacle Church, Incorporated. Said By-laws shall be presented to each and every member prior to them becoming members of the organization.
