The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, here adopt the following Articles of Incorporation:

#### Article I

The name of the corporation shall be Holy Tabernacle Church of Polk County, Incorporated.

#### Article II

The location of the church shall be 4601 Baker Avenue in of Haines City, 33844-8284 state of Florida the County of Polk.

#### Article III

The purpose of this organization is purely religious, moral, uplifting, and civic.

#### Article IV

The membership of the organization shall consist of only those who have met the requirements of the By-laws of the Holy Tabernacle Church, Incorporated. Said By-laws shall be presented to each and every member prior to them becoming members of the organization. The membership is not limited to male or female, and there is no age limit as to qualifications.
