**ARTICLE I**

**-NAME:**

**ARTICLE III**

**-PURPOSE (s)**

**The specific purpose (s) for which the corporation is (are) is to be used for religious services as a means of worship for the New Tabernacle Deliverance Baptist Church, Inc. And to advance the doctrine of the Baptist Demonination, and Equipping it's members to be stronger witness fot the Christian Faith(Acts. 1:8 ) Anyone shall shall qualify as member of this corporation and will be admitted when he or she is accepted by membership guidelines set forth regulating membership found in the Bible.**

**This requirement shall not be deemed to prelude a statement of general purpose of power or to restrict the right of the corporation to engage in other lawful activity.**

**To purchase, receive, take, aquire, hold, sell, convey or otherwise dispose of property, whether it be real, personal or mixed; to receive property by will, and to otherwise require and hold all property,including shares of stock, bond and securities of other Corporation, to wit.**

**Futher, the purpose for which the corporation is organized is exclusively religious, charitable, scintific, and educational within the meaning of section 501-(3) of the Internal Revenue law.**

**upon the dissolution of the corporation, assets shall be distributed to one or more exempt purpose within the meaning of section 501(3)of the Internal Revenue Code, or corresponding section of any future federal tax code of shall distribute to the federal government, or to a state or local government for a public purpose. any such assets not so disposed of by the court of common Pleas of the county in which the principal office of the incorporation is then located exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.**

**ARTICLE IV: The manner in which the Directors are appointed**

**The manner in which the Director or appoint is: the Pastor of the church shall appoint all Directors, and Board member**

**The civil officers of the corporation shall be: The Pastor is President, Chairman Deacons-Vice President, Secretary Treasurer**

- A. The President shall preside at all meeting. sign all certificates, deeds, and other instruments of the corporation**
- B. The Secretary shall keep the minutes of all meeting; shall have charge of the seal and corporate books make such reports.**
- C. The Treasurer shall have custody of all monies and securities of the corporation and shall keep regular books of account.**
