ARTICLES OF AMENDMENT

to

ARTICLES OF INCORPORATION

of

Florida Volunteer Search & Rescue Corps. Inc.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida Corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER (S) BEING AMENDED, ADDED OR DELETED.)

Amending Article III: Purposes

The organizations specific purpose is to provide an environment for teenagers to learn about military customs and prepare them for service in either the military or medical field while also providing a volunteer secondary search unit for local and state agencies. The organization is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes the making of distributions to organizations that qualify as exempt organizations und section 501©(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities no permitted to be carried on by an organization exempt from federal income tax under section 501© (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under section 170© (2) of the Internal Revenue Code, or corresponding.

Amending Article III: Purposes (Continued)

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501© (3) of the Internal Revenue Code, or correspondence section of any future federal tax code or shall be distributed to the federal government or to a state or local government for public purpose. Any such assets not disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the organization is ten located, exclusively for such purposes or to Such organization, as said Court shall determine, which are organized and operated exclusively for such purposes.


