### ARTICLE I:

### ARTICLE III:

The specific purpose(s) for which the corporation is organized is (are):

1. Promote spiritual growth
2. Promote personal growth and develop knowledge of thyself
3. Promote a positive image of women of African descent
4. Seek guidance from elder women of African descent
5. Foster an environment amongst ourselves that is conducive to learning about history and the role women of African descent have played and continue to play in developing this and other nations
6. Develop local leadership to respond to the community needs, particularly those of women of African descent
7. Provide moral and educational guidance to other young women of color in the community
8. Promote unity among people of color
9. Promote a positive image of women of African descent and any thing that positively enhances the survival and well being of women of African descent
10. Provide encouragement and support to men of African descent

These objectives are upheld by the provisions set forth in the official constitution of the founding chapter of Florida State University.

### ARTICLE IV:

The manner in which the directors are elected or appointed is:

1. Candidates shall be nominated by active members of the organization at an open meeting on the second Wednesday of April during the Spring semester.
2. Each nominee is required to make a formal presentation at the open meeting on the second Wednesday in April. The presentation should include the following information: classification, major, all membership and offices of other organizations, athletic affiliation, and candidates qualifications
3. Nominees must be active members who have completed all levels of the Girls Scouts Orientation (9 hours)
4. Candidates will be elected by the majority ( two thirds) vote. Candidates will be asked to leave the voting area during voting.
