any licenses and other rights or interests thereunder or therein.

Sell, convey, mortgage, pledge, lease, exchange, transfer, or otherwise dispose of

all or any part of its property and assets.

- Purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of and otherwise use and deal in and with, shares and other interests in, or obligations of, other domestic or foreign corporations, whether for profit or not for profit, associations, partnerships, or individuals, or direct or indirect obligations of the United States, or any other government, state, territory, governmental district, municipality, or of any instrumentality thereof.
- Lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds loaned or invested except as prohibited by s. 617.0833.

Make donations for the public welfare or for religious, charitable, scientific,

educational, or other similar purposes.

Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the corporation its organized.

Marge with other corporations both for profit and not for profit, domestic and foreign, if the surviving corporation is a corporation not for profit.
