**ARTICLES OF INCORPORATION
OF
MARTIN LUTHER KING MISSIONARY BAPTIST CHURCH INC.**

We, the undersigned, with other persons being desirous of forming a non-profit Corporation, under the provision of chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of this Corporation is:

MARTIN LUTHER KING MISSIONARY BAPTIST CHURCH INC.

The principal place of business of this Corporation shall be 900 N.W. 85th Street, Miami, Florida 33150, and the mailing address of the Corporation shall be the same.

ARTICLE II

The general purpose of the business or businesses to be transacted by this Corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to promulgate the Gospel and to promote the brotherhood of man under God, the Father of all.

ARTICLE III

The membership of this Corporation shall constitute all persons hereinafter named as officers and directors and such other persons who from time to time may become members by joining the church, as provided by Article IV of the Constitution.

ARTICLE VI AMENDMENTS

I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.

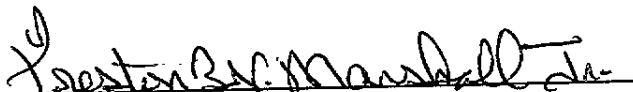
