**ARTICLES OF INCORPORATION
OF
C J 's CHRISTMAS ANGELS, INC.**

The individuals named herein certify that they have associated themselves together for the purpose of forming a corporation not for profit under and by virtue of the laws of the State of Florida and especially under and by virtue of Chapter 617, Florida Statutes, and do hereby adopt the following Articles of Incorporation of such corporation:

**ARTICLE I
NAME**

The name of this corporation is C J's Christmas Angels, Inc.

**ARTICLE II
COMMENCEMENT AND TERM OF CORPORATE EXISTENCE**

This corporation shall commence its existence on the date of subscription and acknowledgment of these Articles of Incorporation, and shall exist perpetually unless dissolved according to law.

**ARTICLE III
GENERAL PURPOSE**

The general powers, objects, purposes, and nature of this corporation shall be as follows:

1. To give the fantasy of Santa to families with a child fighting a terminal illness.

**ARTICLE IV
MEMBERSHIP**

The qualification for members and the manner of their admission shall be regulated by the By-Laws.

ARTICLE V
INITIAL PRINCIPAL PLACE OF BUSINESS AND
INITIAL REGISTERED OFFICE AND AGENT

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which are exempt as organizations described in Sections 501(c) (3) and 170 (c) (2) of the Internal Revenue Code 1986 (as amended), or to the Federal, State, or Local government for exclusive public purposes.

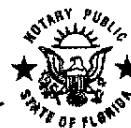
