The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

The corporation shall be named Victory Tabernacle of Prayer For All People, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 364 West Avenue A, Belle Glade, Florida 33430

ARTICLE III

The purposes for which the Victory Tabernacle of Prayer For All People, Inc. is organized are exclusively religious, charitable, literary, and educational within the meaning of section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Upon the dissolution of the corporation, the residual assets of the organization will be distributed to one or more organizations which themselves are exempt as organizations described in section 501©3 and 170©2 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a State or local government for a public purpose.
