ARTICLES OF INCORPORATION
of
WORLD YOUTH SALVATION BY CHRIST JESUS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

Article I

The name of the corporation is the World Youth Salvation By Christ Jesus, Inc.

Article II

The principal place of business and mailing address of the corporation is: 9932 Moorings Drive, Jacksonville, Florida 32257.

Article III

The specific purposes of the WORLD YOUTH SALVATION BY CHRIST JESUS, INC.

1. To spread the true and pure Gospel of our Lord and Saviour Jesus Christ through the Internet also known as the World Wide Web. To accomplish this mission, we will develop web sites to spread the true and pure Gospel of our Lord and Saviour Jesus Christ. This will also be another way for people to communicate with us especially those whom we have ministered to.
2. To spread the true and pure Gospel of our Lord and Saviour Jesus Christ to the people in the campgrounds of the world. Most often these people who visit these campgrounds (like KOA) do not have an opportunity to hear the Gospel. We plan to accomplish this mission by travelling and visiting these campgrounds in the different states and countries and give out leaflets that present the Gospel and where it is permitted by the campgrounds' operators/owners, we will hold Christian Religious services in these campgrounds whenever weather permits or a room is available to hold such service or services. We will also minister on a one to one basis.
3. To spread the true and pure Gospel of our Lord and Saviour Jesus Christ in the Marinas and boating centers and yachting centers of the

world. Most often these people who visit these Marinas, boating centers and yachting centers of the world do not have an opportunity to hear the Gospel. We plan to accomplish this mission by travelling and visiting these marinas, boating centers and yachting centers in the different states and different countries and give out leaflets (tracks) that present the Gospel and where it is permitted by the operators/owners we will hold Christian Religious services in these marinas, boating centers and Yachting centers whenever weather permits or a room is available to hold such service or services. We will also minister on a one to one basis.

4. To spread the true and pure Gospel of our Lord and Saviour Jesus Christ in the different Cruise Lines of the world. Most often the people who go on cruises do not have the opportunity to hear the true and pure Gospel of our Lord and Saviour Jesus Christ. We plan to accomplish this mission by hooking up with the management and operators of the different cruise lines with the objective to get their permission to hold Christian Religious Services in the ships of the different cruise lines.

5. To spread the true and pure Gospel of our Lord and Saviour Jesus Christ in the different sporting events of the world like football games, baseball games, hockey games, horse shows, golf, car races, soccer, etc. We plan to accomplish this mission by going to the different sporting events here in the USA and around the world and give out leaflets that present the Gospel and where it is permitted, we will hold Christian religious services. We will also minister on a one to one basis.

6. To spread the true and pure Gospel of our Lord and Saviour Jesus Christ in the different Flea Markets in the USA and around the world. We plan to accomplish this mission by going to the different flea markets here in the USA and around the world and give out leaflets that present the Gospel and where it is permitted, we will hold Christian religious services. We will also minister on a one to one basis.

7. We will also distribute tracks in public places like public markets, airports etc..

8. We will be likened to travelling Evangelist. And as such, we will encourage those who attend our services or those who accepts our Lord and Saviour Jesus Christ as Lord and Saviour of their life to

attend local churches where they will be nurtured and disciplined to mature and grow in their Christian walk. For those who have Internet access, they can visit with us through the Internet.


