

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
WORLD YOUTH SALVATION BY CHRIST JESUS, INC.**

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendments adopted: Article numbers VI is amended and Article Numbers VII, VIII and IX are added.

Article VI

World Youth Salvation by Christ Jesus, Inc. is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article VII

No part of the net earnings of the World Youth Salvation by Christ Jesus, Inc. shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the World Youth Salvation by Christ Jesus, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the World Youth Salvation by Christ Jesus, Inc. shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the World Youth Salvation by Christ Jesus, Inc. shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code, or

corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal code.

Article VIII

Upon dissolution of the World Youth Salvation by Christ Jesus, Inc., assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed shall be disposed of by the Court of Common Plea of the county in which the principal office of the World Youth Salvation by Christ Jesus, inc. is then located, exclusively for such purposes or to such organization or organization, as said court shall determine, which are organized and operated exclusively for such purposes.
