ARTICLES OF AMENDMENT

00 MAR 21 PM 5: 16

We, the undersigned, hereby make, acknowledge and file these Articles of Amendment to the Articles of Incorporation of <u>His Unspeakable Gift Ministry, Inc.</u>, a corporation not for profit under the laws of the State of Florida, filed of record on March 7, 2000.

- 1. There are no members of the corporation and the Board of Directors are authorized to amend the Articles of Incorporation by resolution of the Board of Directors. These Articles of Amendment were adopted at a special meeting of the Board of Directors on March 16, 2000.
- 2. Article XI is hereby added to the Articles of Incorporation of His Unspeakable Gift Ministry, Inc. and shall read as follows:
 - Article XI. <u>RACIAL NON-DISCRIMINATION</u>. The corporation shall have a racially non-discriminatory policy and therefore shall not discriminate against applicants, students, employees and others on the basis of race, color or national or ethnic origin.
- 3. Article XII is hereby added to the Articles of Incorporation of His Unspeakable Gift Ministry, Inc. and shall read as follows:

Article XII. <u>EXEMPT ACTIVITIES</u>. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
