The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation of such corporation:

ARTICLE 1

The name of the corporation shall be: Cross Stewardship Ministries, Inc.

The principal place of business of this corporation shall be: 1930 Tyler Street, Hollywood, FL 33020.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law. The effective date of this corporation shall be March 4, 2000.
