ARTICLE I

Name

The name of this Corporation is Trade Education Council of SW Florida, Inc.

ARTICLE II

Address

1351 Rail Head Boulevard., Suite 1, Naples, Florida 34110

ARTICLE III

Purpose

Trade Education Council of SW Florida, Inc. is being incorporated as a not for profit corporation to provide support and enhancement and a vehicle for expansion of existing and future trade education programs in Collier County including pre-apprenticeship, apprenticeship, dual enrollment and continuing education programs within the construction industry.

ARTICLE IV

Directors

There shall be four (4) members of the initial Board of Directors of the corporation who will serve until the first election of Directors. The names of the initial directors are as follows:

Section 1: Election/Appointment of Directors: A nominating committee appointed by the Board of Directors shall nominate officers and persons for vacant Directorships on the Board of Directors. Officers and Directors shall be instated by a majority vote of the Board of Directors one month prior to the last meeting of each fiscal year.

Section 2: General Powers. The Board of Directors shall manage the corporation.

Section 3: Number of Directors. The number of Directors shall be not less than four (4) and no more than fifteen (15).

Section 4: Tenure of Directors. The normal term for a Director will be three years. However, no director shall be elected to succeed him/herself after serving six years. Service rendered while filling a vacant seat shall not count toward the six-year limitation period.

Section 5: Vacancies. The Board of Directors shall fill any vacancy occurring on the Board and any Directorship to be filled by reason of an increase in the number of Directors. A Director appointed to fill a vacancy shall serve for the unexpired term of his predecessor. A vacancy shall be created in the office of any Director who fails to attend four (4) consecutive meetings, except for those Directors who have cause acceptable to the Board of Directors for not attending meetings.

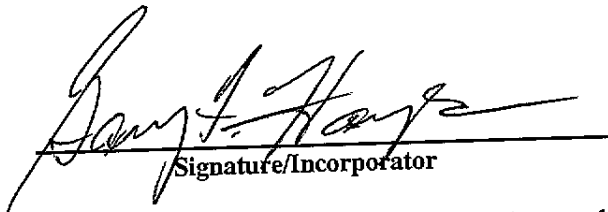
