ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation MAR -8 PM 1: 34

ARTICLE I: NAME:

The name of the Corporation shall be:

ARTICLE II PRINCIPAL OFFICE:

ARTICLE III PURPOSE(S):

The specific purposes for which the corporation is organized are:

- 1) The Corporation is organized pursuant to the Florida Not For Profit Corporation Act, and shall be operated for educational and charitable purposes, and may engage in any lawful activities in furtherance of such educational and charitable purposes. This includes, but is not limited to:
- A) Obtaining internet-ready computers and free or 'inexpensive' online time provided by Internet Service Providers and putting them into the homes of underprivileged, middle-school and high-school (grades 6-12) children with at least a "C" or 2.0 average. Underprivileged children shall be those children considered under the current Federal Guidelines governing the poverty level.
- B) Assisting environmental and solid waste concerns by the recycling of said internet-ready computers.
- C) Assisting women, minorities, the elderly, and/or other 'underprivileged' individuals, etc., in the preparation for either entering the job market, preparing for promotion, or to search for better career opportunities.

This includes, but is not limited to: Working with certain federal agencies, educational organizations or foundations in identifying those children mentioned above; Working with corporations, agencies, organizations or foundations in finding internet-ready computers and free or 'inexpensive' online time; Working with federal, state and local agencies, private businesses, et.al, in recycling internet-ready computers; Assisting in individual resume preparation, interviewing techniques, marketing campaigns and assisting organizations with finding and hiring various exempt and non-exempt employees.

2) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
