ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
of OSCEOLA COUNTY CRACKER DAY INC.

pursuant to the provisions of section 617.1006 Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation

FIRST: 1ST Amendment adopted, Article III Purposes, is amended to read; Said corporation is organized exclusively for charitable and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Also included in purposes, is to show-case, demonstrate, exhibit and preserve the Native American and Early Pioneer History of Osceola County, Florida

2nd Amendment adopted will be ADDED as Article VII Articles of Dissolution: Upon the dissolution of Said Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated for such purposes.

SECOND: The date of adoption of the amendments was January 30, 2001

THIRD: Adoption of Amendments;
