ARTICLES OF INCORPORATION State of Florida [Not-For-Profit]

Article I. The name of the corporation is: "David Kim Perry Foundation, Corporation"

Article II. The temporary principal place of business and mailing address will be:

1132 Killarney Drive
Ormond Beach, Florida 32174

Note: Eventually, I will build a building to house my business operations there.

Article III. The purposes of the corporation are as follows:

1. To travel across the country and host seminars to (2) two wide base audiences. One, *the Church*. This group is comprised of all who believe on Jesus Christ as Lord. The second group consists of account executives and consultants for the television, radio, advertising, medical, and real estate institutions of this great country. One of our divisions named, '**WebPagesToday.Com**,' will handle all of the internet elements of our organization. The main goals of this division is to sponsor and host presentations to Internet users, and host and educate *the Church* on its heritage.
2. We will introduce to both groups our latest in visual graphics - such as, animated pie charts, bar charts, graphs, and movies for their home computers, and the Internet. The primary aim is to show examples of typical periodic, and cyclic trends of a believer's [joint-heir] relationship with the Lord. Then compare those trends with newly revised trends of what God expects from us. The trends will be divided up into hourly, weekly, monthly, quarterly, semi-annual, annual snapshot and animated reports.
3. The charts are interactive, and will show how much time an individual spends basking in the presence of the Holy Spirit, and other important aspects of daily living. The original Web pages **WebPagesToday.Com** makes will feature the latest in audio and video technologies which shall make them extensible for TV. This includes exploring Microsoft's *Advanced Authoring Format*, *RealNetworks*, and *Windows Media* streams. When totally in place, approximately 90% of our designs for Dynamic HTML and applications will be made from (2) two programming languages. They are, Microsoft's Visual J++ 6.0, [Windows Foundation Classes] and Visual C++ 6.0 [Microsoft Foundation Classes].
4. We hope to create interactive Web sites which creates a sense of belonging and community among owners of computers. An additional goal of **David Kim Perry Foundation, Corporation**, is to create important solution - oriented database applications. We will place an emphasis on electronic books, audio, video, and still pictures created for individual and business usage here in America, and around the world.
5. To encourage creativity in professional Web page designs, by actively soliciting Americans for their original ideas. Each idea, if accepted by our firm, will be rewarded with a check starting at \$25. I will put a ceiling on this award in a later admendment.

Article III. The purposes of the corporation are as follows: (continued)

6. To hold regular contests in the form of short quizzes which will test participants of their knowledge of the Bible. The contests will award cash prizes in the form of checks written out to the winners of our daily, weekly, monthly, semi-annual, and annual events. The money prizes will be in the range of \$10 to \$10,000.00 each.

The concept is, the easier the quizzes, the smaller the prize, the potential age for the participants will be low. And, the harder the quizzes, the older you are, the more educated, the larger the prize money.

7. I will build a franchise of multi-purpose office buildings here in Florida and around the country for local small business owners to house their operations in. The name the building will be called is, "*The Substance Pavilion*." This includes a maximum of 7 popular fast food vendors in each franchise. We will invite McDonald's, Burger King, and the like. The fast food vendors will be located on the main floor and atrium. There will be a total of 18 offices. They will be located on the second and 3rd floors. The atrium will have a theater setting that will seat 100 people at a time. Beyond the normal business hours of 8am - 5pm, the atrium will also be used as a gathering place for live seminars and presentations. Popular, well known speakers will be invited from all over the world to come and speak. The seminar hours will range from 10am - 2pm, and 6pm - 11pm.

Article IV. How the Directors are elected or appointed will be implemented in the following way:

I, David Kim Perry, Chairman, CEO, and President, will hand-pick all Board of Director members. The term of their appointment will be for one year - renewable annually at my discretion. Initially, no compensation will be paid in their first year. I will however, pay for their plane fare to and from the place of our annual business meetings when necessary. In this case, funds from my own earnings will be used for this purpose. As of the initial filing of this application, no appointments have been made. At a later time, I will submit an admendment naming the appointees.


