

**FIRST:** Amendment adopted: ARTICLE VII, Section 2, subsection (5)

(5) In the event of dissolution the residual asset of the corporation, Cornerstone Christian Center Church, Inc. will be turned over to Daystar Television Network, Bedford Texas, and/or T. D. Jakes Ministries/The Potter's House Church Dallas Texas, and/or Creflo Dollar Ministries/World Changers Church Int'l, College Park Georgia, and/or Kenneth Copeland Ministries, Fort Worth Texas which each are exempt as an organization as described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or Corresponding Sections of any prior future of the Internal Revenue code, or to the Federal, State, or Local Government for exclusive public purpose.

Notwithstanding any provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on by:

- (a) a corporation exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue Law, or
- (b) a corporation contributions to which are deductible under section 170 (c)
- (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.
