ARTICLES OF INCORPORATION

ONE:

The programs will consist of, but shall not be limited: Youth Education Development, Counseling, Early Childhood Development, Tutorial Program, Computer Literacy, Study Center, Youth and Senior Community Enrichment, Youth at High Risk.

THREE:

The duration of this corporation shall be perpetual, no stock and shall

have no members.

FOUR:

the Internal Revenue Code or (2) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
