ARTICLE I - NAME

The name of this Corporation shall be: Church of God and Christ International, Inc.

ARTICLE II - PRINCIPAL PLACE of BUSINESS and DURATION

This Corporation shall have perpetual existence. The principal place of business and mailing address of this corporation is 680 NW 71 Street, Miami, Florida, 33150.

ARTICLE III - PURPOSE




